Sample Letter to School Officials

Dear _____,

I am writing regarding the emerging risks associated with wireless antennas being installed on or near school buildings across the country. These antennas emit high levels of radio-frequency (RF) microwave radiation (“wireless radiation”) to which students, teachers and staff are exposed throughout the school day. The US National Toxicology Program, part of NIH National Institute of Health, the highest scientific office in the US completed their 10 years, \$25,000,000 study on wireless radiation and health effects. The results were "clear evidence of statistically significant carcinogenic effects". Cancers found were brain, heart, liver, pancreas, pituitary and adrenal gland and prostate.

Over the past several decades, independent researchers have published thousands of peer reviewed scientific studies documenting serious adverse health impacts from exposure to wireless radiation, ranging from neurological and behavioral problems to cancer. According to the International Agency for Research on Cancer (IARC), children absorb up to 10 times more wireless radiation in the bone marrow of the skull compared to adults due to their thinner skulls and higher brain conductivity.

Teachers and staff who are pregnant, or may become pregnant, are also at high risk from wireless radiation exposure. In a 2012 study, researchers at Yale University found that the offspring of exposed lab animals had abnormal brain development and exhibited all the symptoms of attention deficit hyperactivity disorder (ADHD).

Wireless companies claim their antennas and other wireless equipment meet all Federal Communications Commission (FCC) exposure guidelines, and that may be true, but the guidelines themselves are almost 25 years out of date, and are not designed to protect children. In 2013, the American Academy of Pediatrics (AAP) complained to the FCC that its exposure limits do not account for the unique physiological vulnerabilities of children, nor do they reflect current use patterns of wireless devices.

The FCC is currently being sued for ignoring long term, non thermal effects from wireless devices and infrastructure and for not protecting public health from a myriad of illnesses including death, from exposure to wireless devices and infrastructure. Many teachers in the County of Los Angeles have become seriously damaged, some even permanently disabled from teaching in a WIFI infrastructure. Both students and teachers have been given cancer that they are attributing to cell antennas placed on or near school grounds.

The lack of federal guidance on protecting children and the public from exposures to wireless radiation leaves school boards and administrators with the responsibility to do whatever possible to ensure that our children, teachers and staff are safe in this increasingly wireless world. I know that you share my concern for the safety, health and well-being of everyone in our schools, and I urge you to vigorously oppose any effort to place wireless antennas on or near our schools, and to begin to reduce exposure of wireless devices and infrastructure to our children in school by utilizing hard wired internet as opposed to WIFI. Thank you for taking the results of the US National Toxicology Program and the health of our children seriously.
